1. No action or inaction by or payment to the Carolina United Soccer Association, Inc. or any other organization or entity created or established related to the same, its coaches, officers, board members, officials, or those acting on its behalf or associated with the same, (All hereinafter, "CUSA",) shall be deemed to constitute a consent to the above-named child (hereinafter, "player") for registration as a player with Carolina United Soccer Association, Inc.. The inclusion or retention of the player is contingent upon and otherwise conditioned upon compliance with this document's terms and conditions, bylaws and policies and rules of Carolina United Soccer Association, Inc., as they are at the time of registration and as they may be amended thereafter, and those of the North Carolina Youth Soccer Association, all of which the undersigned does hereby consent to and otherwise agree with and agrees to be bound by for himself/herself/themselves and for the players, his/her successors and/or assigns and estate.

2. The above-named Parent/Legal Guardian, on behalf of himself/herself/themselves, and on behalf of any parent or legal guardian of the player who has not also signed below, (hereinafter, "Guardian,") does hereby certify that he or she is a parent or legal guardian of the player with Carolina United Soccer Association, Inc., and bind the player to the terms and provisions hereof, hereintofore and hereinafter. The Guardian does hereby agree and acknowledge that if only one of the parents or legal guardians of the player signs this document, that the same shall not be deemed a lack of consent by the non-signing parent or legal guardian to the terms and provisions hereof, but instead the signature by only one of the parents or legal guardians of the player is sufficient to and does hereby bind any such absentee parent or legal guardian to the terms and provisions hereof and such absentee parent or legal guardian is included as a "Guardian" as stated above.

3. Any heading or title included herein is for convenience purposes and shall not be deemed to limit the effect or scope of any paragraph or section hereof. Any term or provision hereof deemed invalid by a court of competent jurisdiction will not affect any remaining term or provision hereof. The preparer of this document has not provided CUSA, any Guardian or the player with any legal advice, the undersigned does hereby acknowledge that if the undersigned has any question or concern regarding the legal implication of this document, that the undersigned has had sufficient opportunity to obtain or has obtained the advice of legal counsel, and the undersigned does also hereby agree that the preparer of this document shall not be and is hereby held harmless from any and all claims associated in any way with this document or any other claim including or related to CUSA.

4. Medical Consent. Guardian does hereby authorize any one of the adults associated with Carolina United Soccer Association, Inc., after a reasonable attempt has been made to reach Guardian and the above-named Additional Contact Person, if any, to consent to the medical treatment of the player, to thereafter consent to the medical treatment of the player and said medical treatment shall include, but not be limited to, any x-ray, anesthetic, medical or surgical procedure, treatment, or hospital care. CUSA is not responsible and shall not be requested to pay for or reimburse the cost of any such medical care or treatment and is hereby held harmless from the same.

5. Waiver. Guardian, on behalf of the Guardian and player, his/her successors and/or assigns and his/her estate, does hereby, jointly and severally, release, discharge, waive, and agree to hold harmless and indemnify, the North Carolina Youth Soccer Association, United States Youth Soccer Association and CUSA, and any other associated club(s) and anyone who is part of the same, from any and all liability, claims or demands of any and all kind, including but not limited to, any and all liability, claims or demands arising from or otherwise related to, the player's participation in any game, tournament, event or practice or travel to or from the same or otherwise.

6. Code of Conduct. Guardian, on behalf of the Guardian and player, do hereby acknowledge that the appropriate conduct of Guardians and players is conducive to an enjoyable practice or game or tournament, etc., for all of those involved and that inappropriate conduct of a player or Guardian of the same may result in termination of a player with Carolina United Soccer Association, Inc. and North Carolina Youth Soccer Association. Guardian and player do hereby agree to abide by the following rules of conduct, as well as those which may be amended or

supplemented by the bylaws of Carolina United Soccer Association, Inc. for themselves and for those they may invite to a game:

- A. Player and his/her teammate learn by example and this the behavior of Guardian and player will be that of respect for the game and its participants and officials
- B. We will applaud the playing/accomplishments of members of the team which player is a member as well as those of the opposing team
- C. Player will play by the rules and Guardian and player will not question the calls of the game officials or the decision of the coach
- D. Guardian and any of the Guardian's or player's guests to a game shall remain on the side of the field designated by the coach or game official as the 'parent's side' of the field
- E. Neither Guardian, nor any of Guardian's or player's guests to a game, will step upon the field during a game and instead will remain a minimum of six feet from the sideline
- F. Guardian, or any of Guardian's or player's guests to a game, will not stand or be near either end of the field or goal and will not enter upon the coaches' side of the field. However, Guardian may enter the coaches' side of the field only if the player is injured
- G. Guardian is responsible for the behavior and conduct of any of Guardian's or player's guests to a game
- H. Inappropriate conduct, as deemed by the game official, will result in expulsion from the game and premises.

The Guardian and player acknowledge and agree that the above list is not an exhaustive list of the types of behavior, which will not be tolerated as the rules of conduct by be supplemented or amended at any time by the bylaws or rules of Carolina United Soccer Association, Inc., or the North Carolina Youth Soccer Association and/or United States Youth Soccer Association.

7. Permission. Guardian does hereby grant permission for player to participate in practices, games, tournaments, and any other events or gatherings associated with North Carolina Youth Soccer Association, United States Youth Soccer Association and/or Carolina United Soccer Association, Inc. or otherwise in which the player's team participates.

8. The undersigned acknowledges that this document and/or the information contained with it and/or a copy of the player's birth certificate will be submitted to the North Carolina Youth Soccer Association; and/or United States Youth Soccer Association; and/or the coach(es) for the team for which the player plays, or a designee does hereby consent to the same.

9. The undersigned acknowledges that there are four pages to this document and that all four have been read, understood and are agreed with by the undersigned on behalf of the Guardian and by the Guardian on behalf of the player and one signature of the Guardian shall be sufficient to evidence both said consents.
